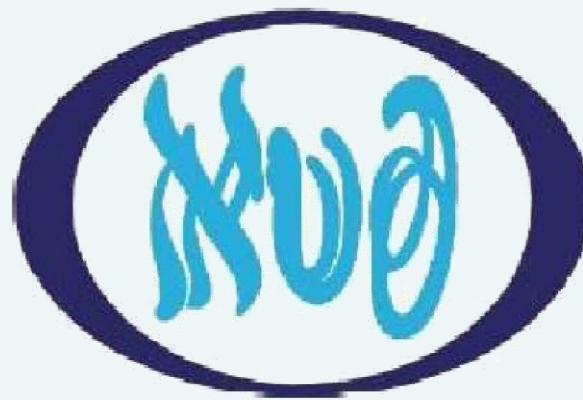

COMPANY OVERVIEW

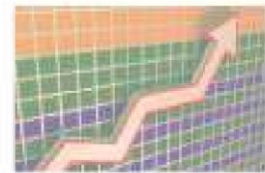
